# **COMMITTEE REPORTS:**

### Minister's Report:

Rev. Jeff Chant reported:

- The Council Retreat held on Saturday, September 14, 2019 was very successful. There was an energy for trying new things with many ideas for outreach. It would be worthwhile to hold retreats several times annually. The following purpose was developed:
  - "To create a vibrant community of followers of Jesus where everyone deeply knows they belong, are cared for, can grow spiritually, and can actively demonstrate our love in the world and towards one another".
- He has been very busy with:
  - Regional duties serving on the Regional Future Directions Committee and supervising the Caledonia pastoral charge.
  - Developing a social media strategy re sermons, messages, etc. A grant of \$4,000 has been received to purchase a camera to record sermons (20 minutes) which will be made available for viewing ~ "Church in 20".
- Rawlins Cross Concert, Oct. 19, 2019 the concert has been 'sold out'. The Ways and Means Committee are coordinating various duties for that evening and will need many hands to help. There was discussion regarding offering food during intermission and, due to the expected congestion in the hallways, it was decided not to offer any food.
- He would like at least 20 minutes at each Council meeting to discuss our purpose and/or have a presentation to increase awareness of community programs and needs. The Inclusivity Committee met today and looked at the Senior Friendly Program. They would like to invite them to the next Church Council meeting on October 30, 2019.

• Lennie Gallant has indicated that he is available to do a concert in the spring of 2020. We need a process for booking concerts to be approved by Council.

Action: Ways & Means Committee to work out the details for the approval process.

Motion: David Walker/Blake Hirtle that we host the Lennie Gallant concert on Friday, May 15, 2019 – details to be worked out. Motion Carried.

# **NEW BUSINESS:**

# **Clarification of District Rep Roles:**

Discussion regarding the roles of District Reps who deliver church communication to members and adherents included:

- The feeling that the reps are just "mail carriers".
- Members who attend church could easily pick up their letters at the church.
- Some persons are not at home/do not answer the door and the reps are unable to meet them in person.
- Should we continue to deliver letters to those who we do not see at church?
- Many people come to the church office to express the fact that they appreciate receiving the correspondence.
- Angela Clifton is getting a lot more calls from District Reps to report issues.

It was agreed by consensus that we should continue the practice of delivering correspondence as is currently in place. Since there is nothing in the Governance Handbook to cover this role, we need to clearly define the expectation and include it in the handbook.

# Motion to Strike a Team to Explore Redevelopment:

<u>Motion</u>: David Walker/Sam Elsworth to strike an ad hoc committee to explore what the possibilities are to redevelop the church property to keep within our Mission but generate a sustainable revenue stream for the future. **Motion Carried.**

### **BUC Mission Team:**

#### Christmas Parade in Bridgewater:

Laurel Cowie advised that the Inclusivity Committee has discussed how to reach the public and is suggesting a float in the Christmas parade held in Bridgewater. It was agreed by consensus that Bridgewater United Church enter a float in the parade with banners reading: "A Place Where Everyone Belongs ~ Bridgewater United Church". Laurel can provide the trailer and a vehicle to haul it.
